THE PROGRAM SERVED 79 WOMEN AND CHILDREN FROM ABUSIVE BACKGROUNDS, PROVIDING REFUGE TO THOSE WHO HAD NOWHERE ELSE TO LIVE DUE TO THREATS OF VIOLENCE. A TOTAL OF 48 WOMEN RECEIVED VOCATIONAL TRAINING TO EMPOWER THEM ECONOMICALLY. ALSO, HAGAR CONTINUED A CAPACITY-BUILDING PROJECT IN AFGHANISTAN TO BUILD A BROAD-BASED COALITION TO RAISE AWARENESS ABOUT HUMAN TRAFFICKING, WITH THE ULTIMATE PURPOSE TO IMPROVE SERVICES PROVIDED TO VICTIMS. ALSO, WE SUPPORTED THE FIRST PHASE OF A PROJECT TO RESEARCH THE SCOPE AND CIRCUMSTANCES OF AFGHAN BOYS TRAFFICKED FOR SEX AND LABOR.
