SPECIFIC PROGRAMS SUPPORTED BY HAGAR USA FUND INCLUDED RESIDENTIAL SHELTER CARE, AN ON-SITE HEALTH CLINIC, CHILDREN'S LONG-TERM EDUCATION, VOCATIONAL TRAINING AND JOB PLACEMENT FOR WOMEN, AND SPIRITUAL NURTURE THROUGH HAGAR CAMBODIA'S SPIRITUAL WELLNESS PROGRAM. HAGAR USA FUNDS HAD A SIGNIFICANT IMPACT ON NEARLY 1,200 INDIVIDUALS IN OUR 2014 HAGAR CAMBODIA PROGRAMS, HELPING THEM REBUILD THEIR LIVES AND BECOME WHOLE AGAIN.

THE PROGRAM SERVED 79 WOMEN AND CHILDREN FROM ABUSIVE BACKGROUNDS, PROVIDING REFUGE TO THOSE WHO HAD NOWHERE ELSE TO LIVE DUE TO THREATS OF VIOLENCE. A TOTAL OF 48 WOMEN RECEIVED VOCATIONAL TRAINING TO EMPOWER THEM ECONOMICALLY. ALSO, HAGAR CONTINUED A CAPACITY-BUILDING PROJECT IN AFGHANISTAN TO BUILD A BROAD-BASED COALITION TO RAISE AWARENESS ABOUT HUMAN TRAFFICKING, WITH THE ULTIMATE PURPOSE TO IMPROVE SERVICES PROVIDED TO VICTIMS. ALSO, WE SUPPORTED THE FIRST PHASE OF A PROJECT TO RESEARCH THE SCOPE AND CIRCUMSTANCES OF AFGHAN BOYS TRAFFICKED FOR SEX AND LABOR.

THEY WERE SUPPORTED IN REINTEGRATION TO COMMUNITY AS THEIR LIVES BECAME WHOLE AGAIN. HAGAR USA FUNDS ALLOWED HAGAR VIETNAM STAFF TO PROVIDE CRUCIAL LONG-TERM AND INTENSIVE CARE TO WOMEN FOR WHOM THERE WERE FEW OTHER AVAILABLE OPTIONS.
