THE FUNDING HELPED TO SUPPORT HAGAR TO DEVELOP CURRICULUM, TRAIN, AND PROVIDE ONGOING COACHING FOR 4 LARGE NGO'S (SERVING TENS OF THOUSANDS OF CLIENTS) ON EFFECTIVE TRAUMA CARE. THE PROJECT CONTINUED IN 2018 WHEN THE TRAINING OF TRAINERS MODEL WAS IMPLEMENTED TO EXPAND THE NUMBER OF ORGANIZATIONS WHO ARE TRAUMA INFORMED AS WELL AS SUPPLEMENTAL TRAINING TO ADDRESS FAITH AND RESILIENCY NEEDS OF TRAUMA SUVIVORS AND DOMESTIC VIOLENCE AWARENESS TRAINING AND TOOLS FOR CHRISTIAN NGO TRAINERS.
